Sheppard BlackEagle Escapes Car Bomb

Sheppard BlackEagle Escapes Car Bomb

August 21st will be a date that our Executive Vice-President Sheppard BlackEagle is unlikely to forget in a hurry. Despite changing his schedule, varying his routes, checking his automobile, and keeping it I a locked garage, terrorists — as yet unknown — still managed to secrete an improvised explosive device — a car bomb —to the underside of his car.

Sheppard recently took possession of an armoured BMW 6 series automobile, complete with an up-rated engine, strengthened passenger compartment, and allround Kevlar and bullet-resistant glass armouring. It is this, and this alone, that saved him from serious injury or even death. That, and his much awed leaden foot, that caused the bomb to be dislodged in the moment prior to the explosion, when he bumped off the driveway of his home, onto the road where he lives.

Despite the apparent lethal damage in the photograph above, The full force of the device impacted behind the passenger compartment, missed him, but wrecked his car. Sheppard managed to get out, before the resulting fire reached the fuel tank, which caused most of the damage to the BMW.

Sheppard's injuries were minimal (bruising, and a small burn to his arm), and he is already back on the job leading BlackEagle's investigation of the incident.

L.A. cell removed from roll - forever By Carter Harrison, (SCL, Los Angeles)

July 21st 2000: In a day that will remain dark for a long, long, time, it has been decided that cell 3, from the L.A. field office, will be deleted from the operational rolls of that office, effective immediately. It will NOT be replaced.

The root cause is a cell that may well have gone bad in its' entirety. Already, one cell member is dead, one missing, believed dead, and the remaining four cell members suspended, stripped of corporate identification and issued equipment, and denied access to company facilities, pending a combined corporate and criminal investigation, where there is, apparently, strong physical, electronic, and circumstantial evidence to prosecute.

A lot of high-level meetings resulted in this action, following several blown or mishandled operations, and one completely confirmed leak of sensitive personal information regarding a confidential informant, who is now missing, and presumed deceased.

The lack of detection prior to the event has, in addition, cost us one damned good senior cell leader, who resigned, citing a lack of his own confidence in managing the office anymore. We in the L.A. office are certain of their guilt, no matter what the DA tells us about innocence to before proving guilt. While we a sorry that one, possibly two, cell members are dead, we cannot, and will not, forget their betrayal of us.

Sydney Olympics Hire BE/BE for CP! By Sid Reed, Ops, Sydney

The Sydney office had an interesting – and sudden – request from the International Olympic Committee in August, to provide Close Protection support to the referees in the Football competition.

Threats from Islamic Fundamentalists, under the terrorist leader Osama bin Laden, had made specific, and quite frightening, threats to kill the referees invigilating the football competition. Police resources were stretched to the 'Nth' degree, so a Private Security company was sought.

However, BE/BE were retained after a report by the New South Wales Police was seen by the IOC, which reported that the company originally hired for the CP contract was not properly trained in CP work. Their main line of work was in Cash In Transit (CIT), not CP work, and thus their contract was invalidated, due to insurance clauses.

At very short notice, BE/BE were asked by the IOC to step in, and, calling in cells from as far a field as New York, Kyoto, London, Marseilles, and Paris, twenty composite eight man teams were formed, to protect the twenty referees under threat.

Only one (1) incident of note was reported by CP Cell 5 (Paris/Marseilles composite cell), who found a hooker in one of the referees' rooms, prior to their taking up their duties. It would appear that the referee was due to be married following the Olympics, and the hooker had been supplied by his friends!

M25 accident kills fifteen, injures seventy-nine

To whit, missions in North Africa, the Eastern Mediterranean, including Israel and Turkey, and Egypt, where a cell was slightly waylaid while on a well earned vacation.

Training Centre by Rachelle Paterson, Range master, Atlanta Training Facility

Hi, and welcome to the first copy of Training Centre; I suppose I should Introduce myself. I'm a former New York Police Department Academy Sergeant Instructor in firearms and tactics. I served fifteen years with the NYPD, and resigned three years back, as it wasn't paying the bills (two kids, and a lovable (fat) Labrador to support!). So here I am. No, there's no photo — I still go out on the occasional op, so I'd rather keep my ugly mug away from cameras!

With this column, we hope to be able to make company employees aware of some of the fine training courses that are available, to help develop job related skills. All courses reviewed will have been attended by BlackEagle employees within six months prior to publishing, and hopefully we will be able to update regularly. All employees attending such courses are requested to submit reports to their L&P representative. For our first column however, we will stay in house.

Beyond the firearms instruction during Basic Training, an operative either learns on the job or by taking outside courses. In this job, what you don't know can get you killed, making On the Job Training (OJT) less than an ideal training environment. Outside courses range from excellent, to less then useless, but are always expensive, and usually require advanced registration that is difficult with a BlackEagle lifestyle.

Therefore, the recent expansion of the range facility at the US BlackEagle Firearms Training Centre, not only allows for additional training classes, but allows for inhouse advanced training courses. Former and active operatives have been recruited as training staff, and have created a first rate training curriculum.

Initial courses will be offered in five fields; Pistol, SMG, Rifle, Precision Rifle and Small Unit Tactics. Shotgun and Fieldcraft may be added later, as demand warrants. All of the courses offered the first year will be at the Practical level. Advanced level courses will be offered in the following years. All courses are five days long, with a class limit of twenty. Five slots will be open to outside law enforcement. There will be at least one instructor per four students.

Please note: The company has no intention of making a profit off training our own operatives, but nor does it intend to go into the red, either. To this end, each course will cost BE/BE operatives \$500, and double that for law enforcement personnel. One meal per day will be provided, and bunks are available. Students supply their own weapons and gear, and will need at least 1000 rounds of ammunition (500 for Practical SUT).

No student may repeat a course, and each of the courses will initially be limited to a maximum of two per year. Course schedules and applications are available from you local L&P Rep, and applications should be submitted through your Senior Cell Leader.

News from L&P... by Todd Bell, L&P, Atlanta

Hi, from Sunny – and loud, as you have heard in this issue – Atlanta.

The recent decision of the US Government to release full MilSpec GPS to consumers has created a flood of new GPS navigation models.

From this point forward Logistics and Procurement will only be carrying these improved models. We will also be initiating an exchange program to speed getting this technology to operatives. Contact your L&P Rep to get the exchange value of your GPS.

Most interesting of the new GPS models is the Magellan GSC1100. In addition to features common on high end models (five coordinate systems, six graphic navigational displays, full-feature course plotter, 200 way point storage, etc), the GSC1100 incorporates email. Utilizing the ORBCOMM system of low Earth orbit satellites Magellan claims coverage of most areas.

However, the features don't come cheap, with a price of \$1000, \$50 activation and \$40 monthly email fee. We are considering making these models the standard issue for out-of-area operations, but don't hold your breath – the testing is in it's early stages.

Now, the above might seem to act against our recent contract with CMI Systems with regard to communications and the BAT III system, but as yet, CMI have nothing to offer in this particular area, so we're going with what's 'on the shelf', and trying, as ever, to get you the best deals possible – watch this space for developments!

Sometimes the contour lines on a map don't do the actual terrain justice. Now with DeLorme's TopoQuad you can get a 3-D look at any point in the US on your computer. Utilizing up-to-date USGS 7.5-minute maps as a base the TopoQuads offer 16 levels of 2-D viewing in addition to 3-D. TopoQuads can measure distance, plan routes, print detailed maps in 2-D or 3-D and can print a cross-sectioned view of a planned route or area. TopoQuads are available for each state and comprise from 7 to 15 CD-ROMs depending on the states size. Prices per state range from \$80 to \$180.

The first time you shoot someone with a taser and have them smile is probably the last time you use a stun gun. Advances in technology have created the M26 by Taser International, the same folks who brought us the AirTaser.

Styled along the lines of a conventional pistol the M26 utilizes wired probes to deliver a 26-watt charge, as compared to 7-watts of the AirTaser, that in tests was 100% effective at incapacitating the subject within half a second. Range is 7 meters.

The M26 also electronically records the date and time of every use, which can then be downloaded via the internal data port for later use. This is an interesting feature, and will, no doubt, be put to the test in a court sometime soon, so BE AWARE of this, should you have cause to use one!

Price is \$399, \$18 for single-use cartridge and \$99 Kydex belt holster.

The Texas Emergency Reserve (military arm of the K-KKK in Texas: established training camps at five rural sites to drill with weapons and practice ambush and demolition tactics; lawsuit by the Southern Poverty Law Centre's Klanwatch Program ordered the camps closed in 1982 when they were found to be in violation of a Texas law over 100 years old which bans "military companies" which privately create a military organization having a "command structure, training and discipline so as to function as a combat or combat support unit" other than those authorized by the governor; SPLC claims over 2,500 were trained by the group). The focus on military training with weapons

weapons and explosives is suspected in connection with a machine-gunning of a gay bookstore that left two dead; using a North Carolina law, the Southern Poverty Law Centre's Klanwatch Project forced the group's leadership to sign a court order prohibiting paramilitary activity; after the group continued to train, the leaders were convicted of criminal contempt, and after appealing all the way to the Supreme Court, were jailed;

SPLC claims over 1,000 were trained by the group).

Another more graphic instance of the greater terrorist inclinations of younger Klan groups is shown by the role of Frazier Glenn Miller, former neo-Nazi and leader of the Carolina Knights of the Ku Klux Klan, in instigating the 3 November 1979 massacre of five leftist anti-Klan demonstrators in Greensboro, North Carolina.
